**OUTCOME OF CIVIL CASE NO BKI B52NCvC 72/11-2017**

The above matter refers.

AFI would like to inform the community that 3 years after the commencement of the court case between SAFODA as the first Plaintiff, AFI as the second Plaintiff and Mr David Bin Mahadus as the First Defendant and 2 others, the Kota Kinabalu Sessions Court ruled in favour for the Plaintiffs, SAFODA and AFI. This ruling was made on 3rd September 2020.

The Judge, having heard the testimonies and upon perusal of all evidence from both parties and having given much consideration thereon, the court found that the Plaintiffs have proven that the 1<sup>st</sup> Defendant has committed the act of trespass on the said land in question, known as Kamanchi-Gandawari located within SAFODA gazetted area. The court has ordered the 1<sup>st</sup> Defendant and his followers;

- i. To remove all the structures built by them from the said Land,
- ii. To vacate and evict from the said Land.
- iii. To not enter and occupy the said Land.

However, it is understood that David Bin Mahadus as the 1<sup>st</sup> Defendant, in this case, has appealed to the court.

SAFODA and AFI will continue to update the community on this case.
